With reference to the subject mentioned above, as the Commission has decided to conduct The National Teachers' Eligibility Test for each discipline of Ayurveda, Siddha, Unani and Sowa-Rigpa of Indian Systems of Medicine for 2024 as per Regulation 8 of National Commission for Indian System of Medicine (National Examinations for Indian System of Medicine) Regulation, 2023, and the same is tentatively scheduled on 19th Nov. 2024, it is to inform you that the TMS request portal for application of fresh teacher codes shall be kept in abeyance till the announcement of results of the upcoming NTET Examination 2024. However, the portal for application for appointment, promotion and change of department shall remain active.

Further, the fresh teacher code applications already submitted in the online portal on or after 24.09.2024 shall be dumped, as the date of notification of the aforementioned examination by NTA was on 24.09.2024 and such applicants have to mandatorily qualify NTET. Such applicants may apply afresh after getting qualified in the upcoming NTET Examination 2024.
